Applicability

This privacy statement applies to all privacy-sensitive information or personal data that you provide to us, for example via a contact or quotation form. We attach great importance to the privacy of our customers and therefore take the greatest possible care in handling and protecting personal data. We process data in accordance with the conditions set out in the General Data Protection Regulation (GPC). Biosoil EU B.V. is the data controller within the meaning of the GCA with regard to the processing of your personal data. This means that we alone determine which personal data are processed, for what purpose and in what way. We are responsible for ensuring that your personal data is processed in a proper and careful manner in accordance with the GTC. In this privacy statement we explain what data we process and for what purposes it is used.

Purpose and principles of processing personal data

If you have not given us your explicit consent to process your personal data or if you have withdrawn your consent, the processing of your personal data may be subject to Articles 6(1)(b), (c) and/or (f) of the GTC. In that case, processing of your personal data may take place without your consent, provided this is necessary for the execution of an agreement to which you are a party, or is necessary for the protection of the legitimate interests of Biosoil EU B.V... In addition, we may have a legal obligation to process your personal data.

We process your personal data for the following purposes:

- Handling your payment
- Sending our newsletter and/or advertising brochure
- Be able to call or email you if necessary to perform our services
- Inform you about changes to our services and products
- To deliver goods and services to you

We will not retain your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

Transmission to third parties

We may share your personal data with third parties if this is compatible with the aforementioned purposes. Provision to third parties may be necessary for the execution of the agreement we conclude with you, may be necessary for the protection of a legitimate interest of ours, or may be necessary to comply with any legal obligation incumbent upon us. With companies that process your data on our behalf, we enter into a processing agreement to ensure the same level of security and confidentiality of your data. We remain responsible for these processing operations. Apart from the previous situations, we will only provide your personal data to other third parties with your express permission.

Commercial purposes

We may use your personal data for commercial purposes, for example to provide you with further information about our services or relevant products or services of carefully selected organisations. In that case, you will only be informed at the e-mail address you have registered. If you do not wish to receive information about relevant

products or services, you can simply indicate this by clicking on "unsubscribe" in the received email. Your personal data will also be used by us for market research and the optimisation of our services. Your personal data will be made anonymous in that context and is therefore no longer traceable to you. Your data will not be sold or shared with third parties for commercial purposes, unless you explicitly consent to this.

Cookies

A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. You can opt out of these cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously stored via the settings of your browser.

We use the following cookies:

- Functional cookies: these are cookies that are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remembers, for example, your preferred settings. They also enable us to optimise our website. These are analytical cookies that do not infringe on your privacy and for which we do not require your prior consent.
- Google Analytics: cookies are used on this website by the American company Google, as part of the "Analytics" service. Biosoil EU B.V. uses this service to get reports on the way the website is used and to measure the quality and effectiveness. We use Google Analytics in the manner prescribed by the Authority Personal Data to be able to fall under the exception in the Cookie Act, so we do not require your prior consent for the use of Google Analytics.
